

Our Notice of Privacy Practices



Effective Date: May 1, 2026

This Notice describes how your health information may be used and disclosed and how you can get access to this information. Please review it carefully.

Who Will Follow This Notice

This Notice describes the privacy practices of our organization's affiliates including:

- All departments and locations of Halifax Health;
- All employees, staff and other personnel of this facility;
- Any healthcare professional authorized to enter information into your medical record while in this facility; and,
- Any member of a volunteer group we allow to help you while you are being served by this facility.

Our Pledge Regarding Your Health Information

We understand that health information about you and your health is personal. We are committed to protecting health information about you. We create a record of the care and services you receive from us. We need this record to provide you with quality care and to comply with certain legal requirements. This Notice applies to the records of your care generated by us, whether made by our personnel or providers involved in your care.

This Notice will tell you about the ways in which we may use and disclose health information about you. We also describe your rights and certain obligations we have regarding the use and disclosure of health information. We are required by law to:

- Make sure that health information that identifies you is secured and kept private;
- Notify affected individuals following a breach of unsecured protected health information;
- Give you this Notice of our legal duties and privacy practices with respect to health information about you; and,
- Follow the terms of the Notice that is currently in effect.

How We May Use and Disclose Health Information About You

The following categories describe different ways that we use and disclose health information. For each category, we will explain what we mean and give at least one example. Not every use or disclosure in a category will be listed. However, all the ways we are permitted to use and disclose information will fall within one of the categories.

For Treatment.

We may use health information about you to provide you with medical treatment or services. We may disclose health information about you to physicians, mid-levels, nurses, technicians, medical students or other personnel who are involved in taking care of you. For example, a provider treating you for a broken leg may need to know if you have

diabetes because this may slow the healing process. In addition, the provider may need to tell the dietitian if you have diabetes so that we can arrange for appropriate meals.

We may disclose health information about you to other healthcare professionals who provide you with healthcare services or supplies as a result of an order from the provider that is overseeing your care. For example, if your physician orders tests or x-rays, we will disclose health information to the specialists that interpret those tests or x-rays.

Different departments may also share health information about you for us to provide the different things you need, such as prescriptions, lab work and x-rays. We may also disclose health information about you to people outside the organization who may be involved in your continuing health care after you leave the facility, such as your family doctor, specialist, another healthcare provider to whom you are referred, family members, clergy or others that provide services that are part of your care.

For Payment.

We may use and disclose health information about you so the services you receive may be paid for by an insurance company or a third party. For example, we may need to give your health plan provider information about surgery you received so the provider will pay us or reimburse you for the surgery. We may also tell your health plan provider about a treatment you are going to receive to obtain prior approval or to determine whether your plan will cover the treatment.

For Healthcare Operations.

We may use and disclose health information about you for healthcare operations. This is necessary to run the organization and make sure that all of our patients receive quality care. For example, we may use health information to review our treatment and services and to evaluate the performance of our staff in caring for you. We may also combine health information about many patients to decide what additional services we should offer, what services are not needed, and whether new treatments are effective. We may also disclose health information to physicians, mid-levels, nurses, technicians, medical students and other personnel for review and learning purposes. We may also combine the health information we have with health information from other facilities to compare how we are doing and see where we can make improvements in the care and services we offer. We will remove information that identifies you from this set of medical information so others may use it to study healthcare and healthcare delivery without learning who the specific individuals are.

Appointment Reminders.

We may use and disclose health information to contact you as a reminder that you have an appointment for treatment or medical care. The information we use or disclose will be limited to the date, time and location of the appointment.

Communications About Halifax Health Affiliates, Treatment Options, Health-Related Benefits, Other Services and Fundraising.

We may use and disclose health information to tell you about our affiliates, our services, treatment options and health-related benefits that may be of interest to you. You have the right to decline these communications. We may also use health information about you to contact you to raise money for equipment, buildings, or programs. We may disclose health information to a foundation related to us so that the foundation may contact you in raising money for the organization. We would release only your name, address, phone number, gender, age, date of birth, health insurance status, the dates you received treatment or services at Halifax Health, the department you were treated in, the doctor you saw, and your outcome information. If you do not want us to contact you for fundraising efforts, you must notify us by phone, email, in writing, or visiting at the contact information listed at the end of this Notice or following the instructions in any fundraising communication. We will honor your decision and will not send you further fundraising communications unless you later choose to receive communications.

Facility Directories and Census Lists.

We may include certain limited information about you in a facility directory or census list while you are a patient. This information may include your name, location in the facility, your general condition (for example, good, fair, serious or critical) and your religious affiliation. The directory information, except for your religious affiliation, may be released to people who ask for you by name. Your religious affiliation may be given to a member of the clergy, such as a priest or rabbi, even if they do not ask for you by name. This is so your family, friends, and clergy can visit you in the facility and generally know how you are doing. We will not provide directory information to the media unless the requesting party provides your name. Media requests for interviews will be conveyed to you or a family member and handled in accordance with your or your family member's wishes. You have the right to restrict the use or disclosure of information contained in a facility directory or census list.

Video, Audio, Photographic, and Radiographic Recordings.

Video, audio, photographic, and radiographic records are used in various medical procedures, such as x-rays, to record the results of those procedures. These records are considered part of your medical record just like written text, and will not be used or disclosed except as described in this Notice. Your visit may be audio-recorded and securely processed by a technology partner to assist your clinician with documentation. Recordings made for research, or for non-medical purposes for you or family members, will only be made with your specific permission. In some cases,

your provider or healthcare staff may restrict when and how recordings may be made. We may use video cameras in certain public areas and care units to help ensure the safety and security of individuals in our facilities. Recordings from these cameras will be used by us only to identify and correct unsafe conditions or investigate possible crimes committed on our premises.

Individuals Involved in Your Care or Payment for Your Care.

We may release health information about you to a friend or family member who is involved in your medical care. We may also give information to someone who helps pay for your care. We may also tell your family or friends your condition and that you are receiving care from us. In addition, we may disclose health information about you to an entity assisting in a disaster relief effort so that your family can be notified about your condition, status and location.

Research.

Under certain circumstances, we may use and disclose health information about you for research purposes. For example, a researcher may review health information to plan a research project, but only if the researcher makes certain representations to us in writing, and the information does not leave the facility unless all identifying information has been removed. Before we use or disclose health information for research, the project must be approved through a special approval process. We will ask for your specific permission if the researcher will be involved in your care at our facility.

As Required by Law.

We will disclose health information about you when required to do so by federal, state or local law. For example, Florida law requires us to report certain injuries that may have been the result of unlawful activity.

To Avert a Serious Threat to Health or Safety.

We may use and disclose health information about you when necessary to prevent a serious threat to your health and safety or the health and safety of the public or another person. Any disclosure, however, would only be to someone able to respond to the threat.

Special Situations

Organ and Tissue Donation.

If you are an organ donor, we may release health information to organizations that handle organ procurement or organ, eye, or tissue transplantation or to an organ donation bank, as necessary.

Military and Veterans.

If you are a member of the armed forces, we may release health information about you as required by military command authorities. We may also release health information about foreign military personnel to the appropriate foreign military authority.

Worker's Compensation.

We may release health information about you for workers'

Compensation or similar programs. These programs provide benefits for work-related injuries or illness.

Health Oversight Activities.

We may disclose health information to a health oversight agency for activities authorized by law. For example, we may disclose health information to the Florida Agency for Health Care Administration, which oversees hospitals in the state. Oversight activities may include audits, investigations, inspections and licensure. These activities are necessary for the government to monitor the healthcare system, government-sponsored programs and compliance with civil rights laws.

Health Information Exchanges.

We participate in certain health information exchanges ("HIE") whereby we may disclose your health information, as permitted by law, to other health care providers or entities for treatment. We have chosen to participate in the Florida HIE through CRISP Shared Services, a provider of health information exchanges serving Florida. As permitted by law, your health information will be shared with this exchange so that your providers at other healthcare organizations or public health officials can access your health information more quickly to support informed clinical decision-making and coordination of your care. You may "opt-out" and disable access to your health information available through CRISP Shared Services by calling 877-940-6144 or completing and submitting an Opt-Out form to Florida HIE by mail, fax or through their website at www.flhie.org.

For more information about the CRISP Shared Services medical record sharing policies, refer to their Notice of Privacy Practices at www.flhie.org.

Lawsuits and Disputes.

If you are involved in a lawsuit or a dispute, we may disclose health information about you in response to a court or administrative order. We may also disclose health information about you in response to a subpoena, discovery request, or other lawful process by someone else involved in the dispute.

Law Enforcement.

We may release health information if asked to do so by a law enforcement official in response to a court order, subpoena, warrant or similar request. We may also disclose limited information about the victim of a crime, a fugitive, or a material witness. Coroners, Medical Examiners, and Funeral Directors.

We may release health information to a coroner or medical examiner. This may be necessary to identify a deceased person or determine the cause of death. We may also release health information about individuals to funeral directors as necessary to carry out their duties.

National Security, Intelligence Activities, and Protective Services.

We may release health information about you to authorized federal officials for national security activities authorized by law. We may also disclose health information about you to authorized federal officials so they may provide

protection to the President, other authorized individuals or foreign heads of state or to conduct special investigations.

Inmates.

If you are an inmate of a correctional institution or under the custody of a law enforcement official, we may release health information about you to the correctional institution or law enforcement official. This release would be necessary for the institution to provide you with healthcare to protect your health and safety or the health and safety of others; or for the safety and security of the correctional institution.

Reproductive Health Care.

We will not use or disclose health information regarding reproductive health care if the request is made to investigate or impose liability on any person for the act of seeking, obtaining, providing, or facilitating reproductive health care where such health care is lawful.

If we receive a request for health information for health oversight activities, judicial and administrative proceedings, law enforcement purposes, and coroner and medical examiner duties potentially related to your reproductive health care, we are required to obtain a signed attestation confirming that the use or disclosure is not for a prohibited purpose. Information disclosed in accordance with this notice and applicable law may be subject to redisclosure by the recipient and may no longer be protected by the HIPAA Privacy Rule. *Substance Use Disorder (SUD) Information.*

We may receive SUD treatment information from providers or programs covered by 42 CFR Part 2, other HIPAA covered entities (that are not Part 2 Programs), or the business associates of HIPAA covered entities. For example, we may only receive SUD treatment information that is subject to Part 2 if you consent to the disclosure or as otherwise permitted by law. When we lawfully receive such information, we will only use and disclose it if you provide us with your written consent for the use or disclosure, a court order entered after notice that meets the requirements of Part 2 authorizes the disclosure, or the disclosure is permitted without your consent by Part 2 regulations (such as in the case of medical emergencies, to public health authorities in certain cases where the records have been de-identified, or for scientific research, audit in certain cases, etc.).

We will not use or disclose substance abuse disorder records, subject to 42 CFR part 2, without a court order or your written consent in civil, criminal, administrative, or legislative proceedings against you. Your Rights Regarding

Your Rights Regarding Your Health Information

You have the following rights regarding health information we maintain about you:

Right to Access.

You have the right to access health information that may be used to make decisions about your care. Usually, this includes medical and billing records, but does not include psychotherapy notes. To access health information that may be used to make decisions about you, you may sign up for the patient portal, contact the Health Information Management

department by phone, email, or submit your request in writing to the address listed at the end of this Notice. If you request a copy of the information, we may charge a fee for the costs of copying, mailing, or other supplies associated with your request.

We may deny your request to access your information in certain limited circumstances. If you are denied access to health information, you may request that the denial be reviewed. Another licensed healthcare professional chosen by management will review your request and the denial. The person conducting the review will not be the person who denied your request. We will comply with the outcome of the review.

Right to Request Amendments or Corrections.

If you feel that health information we have is incorrect or incomplete, you may ask us to amend or correct the information. You have the right to request an amendment for as long as the information is kept by or for us. To request an amendment, your request must be made in writing and submitted to the address listed at the end of this Notice. In addition, you must provide a reason that supports your request.

We may deny your request for an amendment if it is not in writing or does not include a reason to support the request. In addition, we may deny your request if you ask us to amend information that:

- Was not created by us, unless the person or entity that created the information is no longer available to make the amendment;
- Is not part of the health information kept by or for us;
- Is not part of the information which you would be permitted to access; or,
- Is already accurate and complete., you are still entitled to a paper copy of this Notice.

Right to an Accounting of Disclosures.

You have the right to request an "accounting of disclosures." This is a list of the disclosures we made of health information about you, other than for treatment, payment, or healthcare operations as described above.

To request an accounting of disclosures, you must submit your request in writing to the address listed at the end of this Notice. Your request must state a time period which may not be longer than six years and may not include dates before April 14, 2003. For lists, we may charge you for the costs of providing the list. We will notify you of the cost involved and you may choose to withdraw or modify your request at that time before any costs are incurred.

Right to Request Restrictions.

You have the right to request a restriction or limitation on the health information we use or disclose about you for treatment, payment or healthcare operations. You also have the right to request a limit on the health information we disclose about you to someone who is involved in your care

or the payment for your care, like a family member or friend. For example, you could ask that we not use or disclose information about a surgery you had.

We are not required to agree to your request unless the disclosure is for the purpose of carrying out payment or health care operations, it is not otherwise required by law, and the information pertains solely to an item or service for which you, or person other than a health plan on your behalf, have paid fully.

If we do agree, we will comply with your request unless the information is needed to provide you emergency treatment.

To request restrictions, you must make your request in writing to the address listed at the end of this Notice. In your request, you must tell us what information you want to limit, whether you want to limit our use or disclosure, or both and to whom you want the limits to apply, for example, disclosures to your spouse.

Right to Request Confidential Communications.

You have the right to request that we communicate with you about health matters in a certain way or at a certain location. For example, you can ask that we only contact you at work or by mail.

To request confidential communications, you must make your request by email or in writing to the address listed at the end of this Notice. Your request must specify how or where you wish to be contacted. We will not ask you the reason for your request. We will attempt to accommodate all reasonable requests.

Right to a Paper Copy of This Notice.

You have the right to a paper copy of this Notice. You may ask us to give you a copy of this Notice at any time. Even if you have agreed to receive this Notice electronically, you are still entitled to a paper copy of this Notice.

You may obtain an electronic copy of this Notice at our website halifaxhealth.org. To obtain a paper copy of this Notice, contact us at the address listed at the end of this Notice.

Choose Someone to Act for You.

If someone has authority to act as your personal representative, such as if someone has your medical power of attorney or if someone is your legal guardian, that person can exercise your rights and make choices about your health information.

Changes To This Notice

We reserve the right to change this Notice. We reserve the right to make a changed Notice effective for health information we already have about you as well as any information we receive in the future. We will post a copy of the current Notice in prominent locations in our facilities and

on our website.

The Notice will contain the effective date in the heading. Each time you register for healthcare services as an inpatient or outpatient, we will offer you a copy of the current Notice in effect.

Epic MyChart Patient Portal

MyChart at Halifax Health is a secure, convenient online tool that empowers you to take an active role in your healthcare journey. Through this personalized portal, you can access your medical records, communicate directly with providers, request prescription refills, schedule appointments, and manage billing, all from the comfort of your home. Other Uses of Health Information

Other uses and disclosures of health information not covered by this Notice or the laws that apply to us will be made only with your written permission. If you provide us permission to use or disclose health information about you, you may revoke that permission, in writing, at any time. If you revoke your permission, we will no longer use or disclose health information about you for the reasons covered by your written authorization.

Understand that we are unable to take back any disclosures we have already made with your permission, and that we are required to retain our records of the care that we provided to you. Examples of uses and disclosures for which your specific written authorization is required, subject to exceptions described in the privacy regulations, include:

- Psychotherapy notes;
- Marketing; and,
- Sale of protected health information.

Discrimination is Against the Law
